

B7s x Myzone Prize draw

Official Rules



This prize draw is only open to registered MYZONE® users and is free of charge.

TERMS & CONDITIONS

1. **SPONSOR.** The B7s x Myzone prize draw ("B7s x Myzone Prize draw") is sponsored by Myzone Group Limited ("Sponsor") of 5th Floor, Market Square House St James Street Nottingham, NG1 6FG.
2. **ELIGIBILITY.** The B7s x Myzone Prize draw is only open to individuals who are aged eighteen (18) years or older on the date of entry ("Eligible Persons"). Employees of Myzone Holdings Limited and its subsidiary undertakings, as well as members of the immediate family (spouse, parents, siblings, and children) and household members of each such employee or anyone else professionally connected with this B7s x Myzone Prize draw, are not eligible to participate. This B7s x Myzone Prize draw is void where prohibited by local or national laws. It is the responsibility of Eligible Persons to ensure that they are legally eligible to participate and accept the award.
3. **B7S X MYZONE PRIZE DRAW PERIOD.** The B7s x Myzone Prize draw will run throughout the Bournemouth 7s Event 2023 – from 12:00 pm on the 26th of May 2023 until 02:00 pm on the 28th of May 2023 ("the "Challenge Period").
4. **CHALLENGE.** During the Challenge Period, one entry voucher ("Voucher") will be awarded based on one Voucher for each Myzone user registering their details during the event at the Myzone tent (each a "Registered Entrant").
5. **LIMIT.** There is a limit of one Voucher per person.
6. **PRIZES.** Prizes totalling £2,500 will be awarded as follows:
1 x winner £2,500.
The winner will be announced on the 28th of May 2023 at the Bournemouth 7s event, and their winning amount provided by bank transfer.
7. **AWARD.** The odds of winning an award depend on the number of qualifying Registered Entrants during the Challenge Period.
8. **METHOD OF ENTRY.** There are two methods of entry:
 1. The individual purchases a Myzone device during the Bournemouth 7s event, from the Myzone tent.
 2. The individual shows proof of using Myzone at the Bournemouth 7s event and registers their details at the Myzone tent during the Challenge Period.
9. **POOL.** The winner will be drawn from the pool of Vouchers earned during the Challenge Period. This will be done via a random number generator, activated by a third party.
10. **REGISTRATION.** The Registration Period will begin at 12:00 pm on the 26th of May 2023 and close at 02:00 pm on the 28th of May 2023. All times are based on BST.

11. **WINNERS AND NOTIFICATION.** The winner of the B7s x Myzone Prize draw will be selected via a random process on the 28th of May 2023 at the Bournemouth 7s event. The winner will be notified by no later than the 10th of June 2023.

The winner will be required to respond within 14 days of notification confirming their acceptance of the award and sign and return an Affidavit of Eligibility and Liability/Publicity Release. In the event a winner: i) does not respond to communications within 14 days of notification, ii) declines or does not redeem the award, iii) cannot be verified as eligible, as described below, or iv) fails to provide a signed Affidavit, the Sponsor reserves the right to disqualify that winner and present the award to a reserve winner identified using the above process or failing that, present the award to a charity, at its sole discretion.

12. **GENERAL.** Entries that do not satisfy the requirements of these Official Rules in full will be disqualified and will be discarded. If it becomes apparent that a participant is using a system or process that is not consistent with the spirit of the challenge that person's entries will be disqualified and any award will be void.

Sponsor may, at its sole discretion, disqualify entries deemed to be non-compliant with these Official Rules and reserves the right to refuse entry to or disqualify any entrant whose conduct may be unlawful or otherwise bring Sponsor into disrepute. Furthermore, if the Sponsor so elects, the prize winner may be required to submit to a confidential background check to confirm eligibility and to help ensure that the use of any such person in advertising or publicity will not bring the Sponsor into disrepute, and Sponsor may disqualify such winner based on the results of the background check, at Sponsor's election. In the event of such disqualification, the Sponsor may present the award to another entrant.

13. **LIMITATIONS OF LIABILITY.** Sponsor accepts no responsibility for failing to register Myzone users in the B7s x Myzone Prize draw or for late, incomplete, incorrectly processed, corrupted or misdirected entries.

If for any reason any aspect of this B7s x Myzone Prize draw is not capable of running as planned, including by reason of event cancellation, computer virus, network failure, bugs, tampering, unauthorized intervention, fraud, technical failures or any cause beyond our control which corrupts or affects the administration, security, fairness, integrity or proper conduct of this B7s x Myzone Prize draw, the Sponsor may at its sole discretion cancel, terminate, modify or suspend the B7s x Myzone Prize draw, or invalidate any affected entries.

The Sponsor will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense or damage which is suffered or sustained (whether or not arising from any person's negligence) in connection with this B7s x Myzone Prize draw or accepting of the award, except for any liability which cannot be excluded by law (including personal injury, death and fraud) in which case that liability is limited to the minimum allowable by law.

By participating in this B7s x Myzone Prize draw, each participant is agreeing to be bound by these Official Rules (and the decision of Sponsor, which shall be final in all respects), and agrees to release Sponsor its directors, officers, employees and agents from, and indemnifying each of them against, any and all liability or any loss, damage or injury of any kind arising from or in connection with this B7s x Myzone Prize draw.

Sponsor reserves the right to withdraw or suspend any Registered Entrant if there is any breach of these Official Rules.

The Myzone® device must at all times be used in accordance with the Myzone product use and care instructions.

16. **GOVERNING LAW AND DISPUTES.** Any and all disputes, claims and causes of action arising out of or connected with this B7s x Myzone Prize draw or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively under the laws of England and Wales. Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this B7s x Myzone Prize draw, but in no event legal fees; and under no circumstances will an applicant for entry or Registered Entrant be permitted to obtain awards for, and each hereby waive all rights to claim, indirect, punitive, incidental and consequential damages and any other damages (other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the B7s x Myzone Prize draw, shall be governed by, and construed in accordance with, the laws of England and Wales, without giving effect to any choice of law or conflict of law rules which would cause the application of the laws of any jurisdiction other than England and Wales.
17. **INTERPRETATION.** It is the Sponsor's intention that all provisions of these Official Rules be strictly enforced. In the event that one or more of the provisions set forth in

these Official Rules protective of the Sponsor are not fully enforceable under applicable English law, such provisions shall be reduced in scope in such limited fashion so as to make such provisions enforceable under applicable English law in such full and complete manner as possible.
